KNOW ALL MEN BY THESE PRESENTS:

That we, _____, as principal and the other undersigned subscribers hereto as surety, acknowledge ourselves to owe and be indebted to the City of Sherman, a Municipal Corporation of Grayson County, Texas, in the sum of ONE THOUSAND DOLLARS (\$1,000.00), for the payment of which, well and truly to be made, we hereby bind ourselves, our heirs, administrators and executors, and the successors or successor of the corporate signers hereof jointly and severally firmly by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH THAT the said principal desires to engage in the construction and repairing of concrete and cement sidewalks and other concrete and cement construction and repair work, and desires to comply with the ordinances of said city relating thereto.

NOW THEREFORE, if the said Principal shall do all such work done or undertaken by said principal in good and workmanlike manner and in strict compliance with the ordinances, rules and regulations of said city now in force or which may hereafter be adopted by it in reference to the construction and maintenance of concrete or cement construction or repair work,

AND IF the said principal shall at all times fully indemnify the said City for all damages occasioned by the neglect or unskilled work of said principal and the agents and employees thereof,

AND IF the said principal shall indemnify and save harmless persons, firms and corporations for which said principal shall construct or repair sidewalks or other concrete or cement work within said City against and on account of all damages occasioned by the failure of said principal to strictly comply with all the ordinances and rules and regulations of said City governing the construction and repair of concrete and cement sidewalks and other concrete or cement construction or repair work;

THEN this obligation shall be null and void.

This bond shall remain in full force and effect for a period of one year from the date set forth below.
